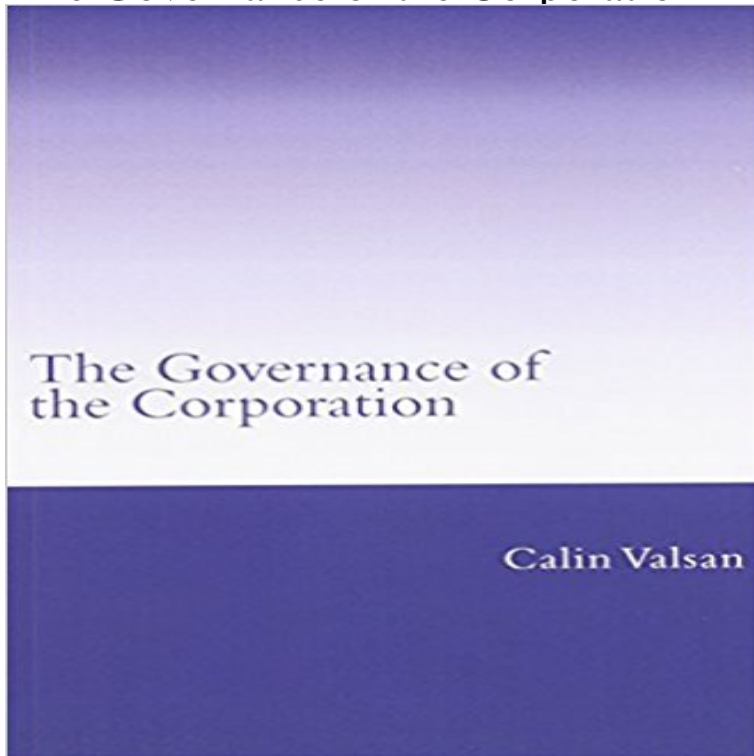


The Governance of the Corporation
