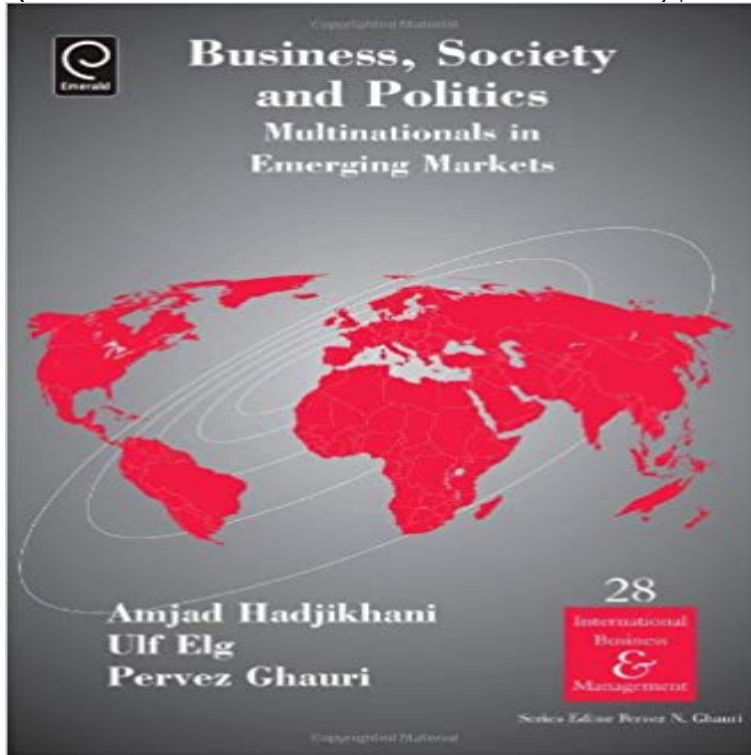


## Business, Society and Politics: Multinationals in Emerging Markets (International Business and Management)
