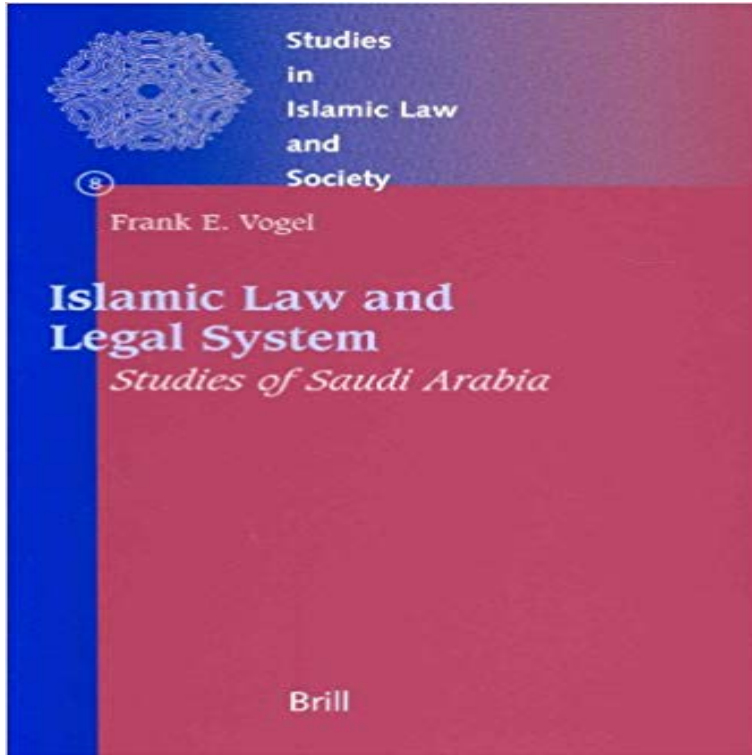


Studies in Islamic Law and Society, Islamic Law and Legal System: Studies of Saudi Arabia
