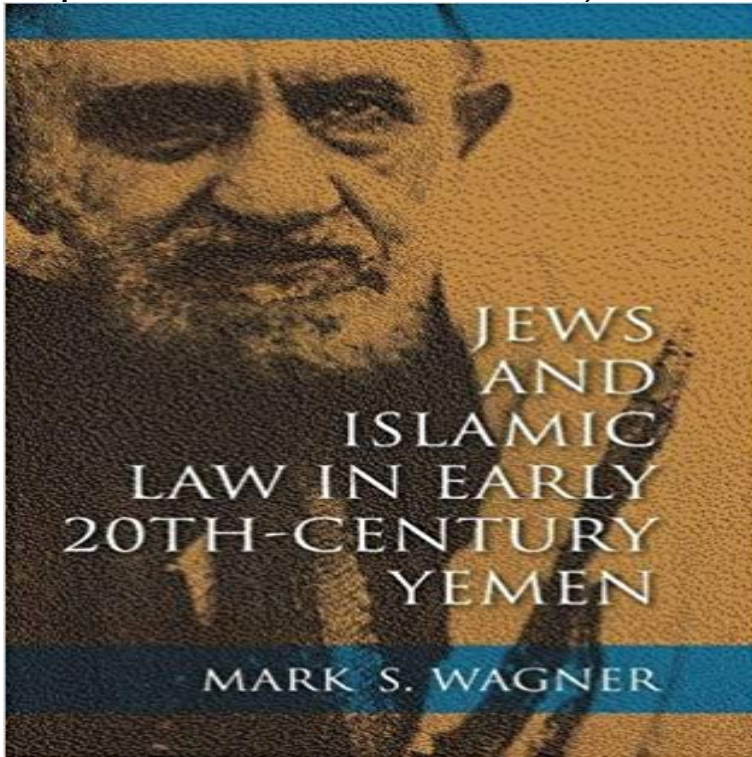


## Jews and Islamic Law in Early 20th-Century Yemen (Indiana Series in Sephardi and Mizrahi Studies)
