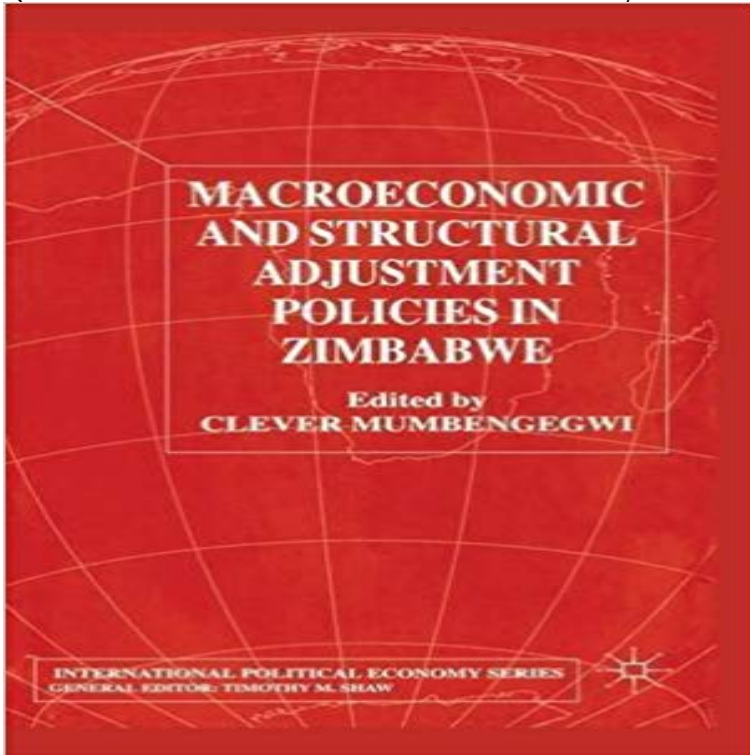


# Macroeconomic and Structural Adjustment Policies in Zimbabwe (International Political Economy Series)
