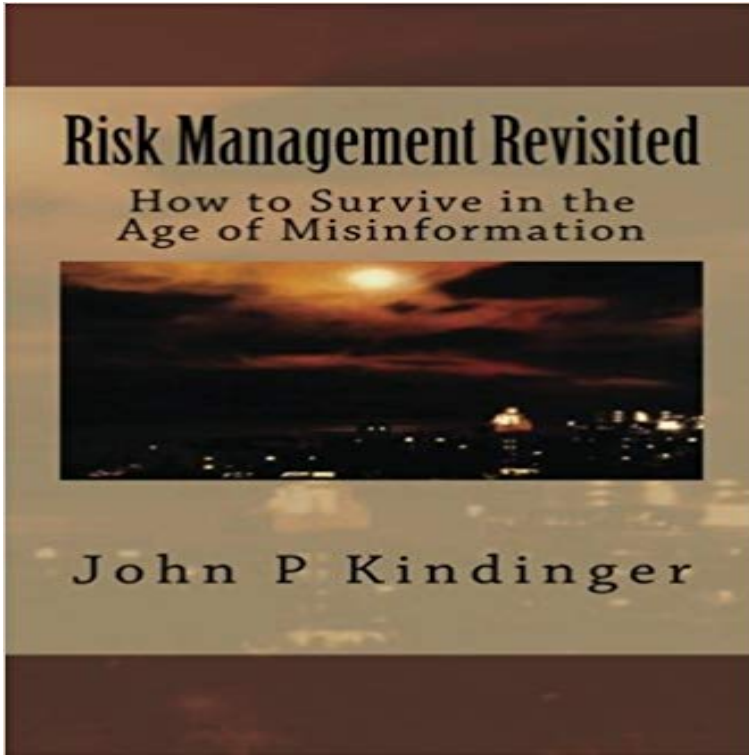


Risk Management Revisited: How to Survive in the Age of Misinformation
