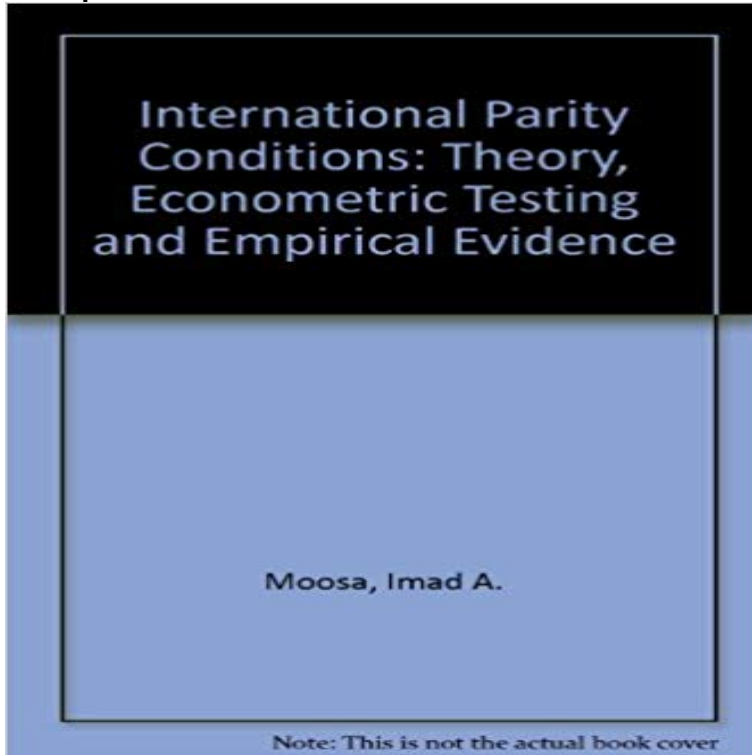


International Parity Conditions: Theory, Econometric Testing and Empirical Evidence
