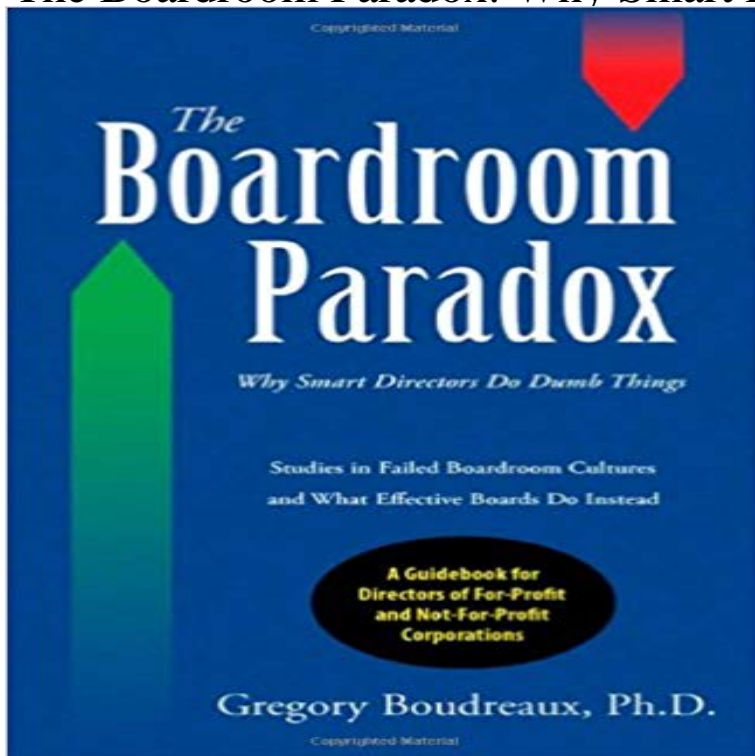


The Boardroom Paradox: Why Smart Directors Do Dumb Things
