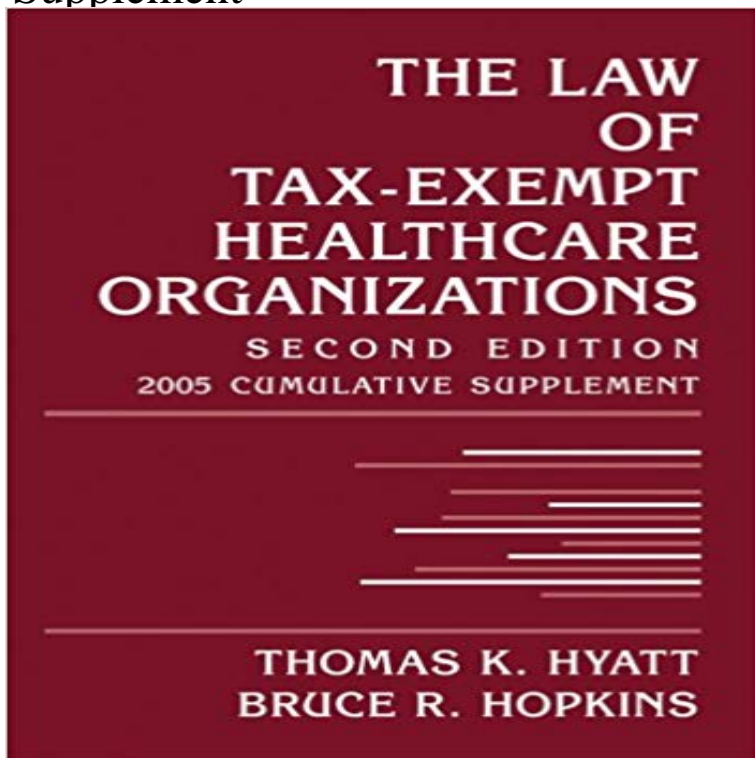


The Law of Tax-Exempt Healthcare Organizations: 2005 Cumulative Supplement
